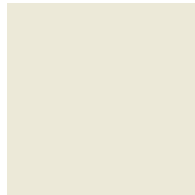
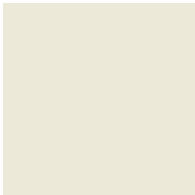

Directions to Archway

From Elkton - South on Rt. 213 for about 13 miles. As you are crossing the Bohemia River, put turn signal on for a right turn, for Glebe Road. This will be a hair pin turn immediately after the bridge.

Continue on Glebe Rd. until end about 3 or 4 miles. to Rt. 282. turn right. about 3 miles down the road will be a slow down area with ripple bumps. The Archway will be on you right just after that on the curve. If you pass it you will be in Crystal Beach

From the south. travel north on rt 301 until you come to rt.313. this will turn to 213 at light in Galena. Travel north on 213 to Rt 282. turn left. About 6 miles down the road will be a slow down area with ripple bumps. The Archway will be on you right just after that on the curve. If you pass it you will be in Crystal Beach Attached is a Map of the area.
